

# “Win a trip of your dreams!” competition terms & conditions

1. The promoter is: FONA Dental s. r. o (company no. 45 691 118) whose registered office is at Štefánikova 7, Bratislava 811 06, Slovak Republic.
2. The competition is open to authorized FONA Dental dealers and sales representatives only.
3. Downloading the FONA AR app and registering a user profile is required to enter this competition. There is however no entry fee and no purchase necessary.
4. By entering this competition, the entrant is indicating his/her agreement to be bound by these terms and conditions.
5. Route to entry for the competition and details of how to enter are via [www.virtualshowroom.fonadental.com](http://www.virtualshowroom.fonadental.com) . No other social media platforms are used for the competition to run on.
6. Only one profile will be accepted per person. Multiple entries of profiles from the same person will be disqualified.
7. The closing date for entry will be 31/10/2016. After this date no further entries to the competition will be permitted.
8. No responsibility can be accepted for entries not received for whatever reason.
9. All entries and uploads submitted must adhere to the ethical code of conduct of FONA Dental s.r.o. and must therefore not be offensive, pornographic, violent, or of any other nature considered as inappropriate.
10. All submissions of “Virtual Showrooms” entered into the competition must be made with the FONA AR app and must come from real business presentations made for existing or potential

clients. This and only this shall be considered a valid “Virtual Showroom” and only this constitutes a valid submission.

III. Screenshots of these “virtual showrooms” are then subsequently uploaded to the website mentioned above, under the entrant’s profile.
